

# TICKETS BAGS REAL ID



By **May 7, 2025**, people 18+ must have **REAL ID** or other federally approved ID to fly in the U.S.



A REAL ID is a state-issued driver's license, instruction permit or identification card that meets federal security standards. Starting May 7, 2025, every air traveler 18 years and older must present REAL ID or other federally approved identification, like a U.S. passport or military ID, to board a flight within the U.S. and access certain federal facilities. To get a REAL ID, you need to bring in necessary documents for **PROOF OF IDENTITY, NAME AND RESIDENCE ADDRESS**. ## PROOF OF IDENTITY

**These documents must be originals** or certified copies. Electronic or photocopies are **not** acceptable.

You must submit **ONE** of the following unexpired documents:

- U.S. passport or U.S. passport card.\*
- U.S. birth certificate issued by a state or local government.
- Certificate of Citizenship.
- Certificate of Naturalization.
- Consular Report of Birth Abroad.
- Permanent Resident Card.
- Employment Authorization Card.
- Foreign Passport with unexpired U.S. visa and valid I-94 issued by DHS.
- Foreign Passport from Micronesia, the Marshall Islands, or Palau and a valid I-94 issued by DHS.

\* Recently issued passports or passport cards may not verify through the national verification system.  
Please come prepared with additional proof of identity from this list.

## PROOF OF NAME

If your **full legal name** is not listed on the identity document you submit, you must also submit **ONE** of the following documents that shows your **full legal name**:

- Oregon driver's license, instruction permit, or identification card, expired no more than one year.
- Out-of-state driver's license, expired no more than one year.
- Tribal ID card issued by a federally recognized tribe located in Oregon or with an Oregon affiliation, approved by DMV.
- Oregon Concealed Weapon Permit or Concealed Handgun License, expired no more than one year.
- Military ID card, Common Access card, Uniform Services ID & Privilege card, including all branches of military personnel and dependents but not including Merchant Marines.
- Canadian government-issued birth certificate.
- Official government-issued marriage certificate or license.
- U.S. city, county or state court-issued legal name change decree.
- Record of Domestic Partnership issued by Oregon Vital Statistics.
- Out-of-state government-issued record of Domestic Partnership.
- U.S. city, county or state court-issued divorce decree, judgment of dissolution of marriage, annulment of marriage decree, judgment of dissolution of domestic partnership or annulment of domestic partnership.
- Government-issued death certificate of spouse that includes your current full legal name.
- U.S. city, county or state court-issued adoption decree.
- U.S. city, county or state court-issued custody decree or guardianship decree.

## PROOF OF ADDRESS

You must submit **TWO** documents that show your current name and current Oregon residential address.

**The documents must be from two different sources.** Each document you submit:

- Must contain the **physical** address where you reside and not a mailing address or P.O. Box.
- Must come from a verifiable business or government agency.
- Must be written in ink if handwritten.
- Cannot include any alterations such as erasures or information crossed out.
- Cannot include a forwarding address sticker or label.

Submit **TWO** of the following documents:

- Oregon driver's license, instruction permit or identification card, expired no more than one year, OR an Oregon vehicle title or registration card.
- Any item delivered by the U.S. Postal Service, FedEx, or UPS sent by a verifiable business or government agency.
- Utility hook-up order or utility statement issued by the service provider.
- Any document issued by a financial institution that includes your residence address.
- Rental or lease agreement that includes the original signature of the lessor or landlord.
- Oregon voter notification card or voter profile report or Selective Service card.
- Any document issued by an educational institution.
- Any document issued by an insurance company or agent.
- Paycheck, pay stub, W-2 or 1099 tax form.
- DMV form 735-7480, Affidavit of Shared Residence, completed by any person living at the same residence address you listed on your application. Person must accompany you to the DMV and provide their own proof of address.
- U.S. government-issued marriage certificate or license signed by a government official.
- Loan agreement, payment booklet or voucher, or loan statement.
- Oregon Department of Consumer & Business Services-issued manufactured structure ownership document.
- Medical or health benefits card.
- Unexpired professional license issued by an agency in the U.S.
- Current Certificate of Eligibility for Exchange Visitor (J-1) status (DS2019).
- Approved letter from Oregon State Hospital, homeless shelter, transitional service provider or halfway house dated within 60 days of your application certifying your residence address.
- Letter from Department of Veterans Affairs Rehabilitation Center & Clinics certifying your address.
- Letter on company letterhead from an employer certifying you live at a non-business address owned by the business or corporation.
- Any document DMV accepted as proof of legal presence that contains an address.
- Any document accepted as proof of identity, such as an Oregon Concealed Weapon Permit or Concealed Handgun License that contains an address.

## NEXT STEPS

- Schedule an appointment at [dmv2u.oregon.gov](https://dmv2u.oregon.gov) or walk into any DMV office.
- Bring the documents you need from this list as proof of identity, date of birth, name and address.
- Bring \$30 for the REAL ID surcharge in addition to all other applicable fees.
- If you are eligible for a Social Security number, you must verbally give your SSN when you apply (you do not need to bring your card). Your SSN will be verified with the Social Security Administration using your legal name.
